Description of the ARTEM OCC

Theme: A holistic and integrated approach to creativity, innovation and sustainability in the age of disruption

Current social life and economic situations are challenged by complex disruptive events. Global interdependence implies that these disruptive events can no longer be locally limited, however, as they have far-reaching effects worldwide which are felt in a holistic manner. Examples that have been widely discussed are social imbalance within and between ecosystems, exploitation and environmental destruction or territorial and ethical conflicts. The current most disruptive events, are the global pandemic of COVID-19 and the Ukraine war, with its political, humanitarian, ecological and economic ramifications. Dealing with such disruptions in a sustainable way requires radical new solutions and, therefore, changes in mindsets and behaviour. Reactions and solutions need to provide future perspectives and not to bring about further destructive side effects. This requires creativity, sustainable thinking and innovation in a multidimensional and transdisciplinary way.


Disruptive events such as COVID-19 or the Ukraine war can also be seen as a trigger for pending imbalances and dangers, e.g. a fundamental imbalance between social and economic activities as well as earth systems. It shows that strategies of dealing with crises and actions are of diverse quality around the globe and particularly with regard to multiple overlaying effects. Actions taken may prevent the worst outcome in the short term or only shift problems. Holistic approaches beyond a theoretical conceptual level, on how to deal with the global challenges in the long run and on an action level, are rather rare. Disruptive events also demonstrate their disturbing impact on existing and continuous practices. In exceptional situations, such as the COVID-19 pandemic, one has to consider the big picture and envisage strategies beyond traditional approaches to crisis management. It is, therefore, required to see beyond the external manifestation of the crisis and investigate its significance. Hence, disruption can also be considered as a wake-up call against an unreflected continuation of present behaviour, which embraces traditional approaches to identify challenges. New solutions can either be a reaction to disruptions or disruptions themselves.

The 2023 ARTEM OCC symposium seeks to address actions related to connecting creativity, innovation and sustainable development and how these connections can move people, organizations and societies towards sustainability in various fields. In the upcoming edition we intend to address visions of the interrelationship and integration of creativity, innovation and sustainability towards forms of coping with unforeseen crises in a sustainable way. The main stream of the symposium is to build on the inspiring outcomes of previous ARTEM OCC conference editions and create a discursive space among academics, practitioners and doctoral students in various disciplines.


