Dear Colleagues,

The School of Business, Economics and Law of CUNEF University is pleased to announce its 1st International Week, which will be held from the 8th. to the 12th. of April, 2024. It will be an opportunity for academics to give visiting lectures at our university under the Erasmus+ Teaching & Staff Mobility Programme, where applicable.

Academics are welcome to propose lectures in a variety of subjects/topics (see the complete list below). The lectures (minimum required: 3 hours) target Graduates.

The teaching language is either English or Spanish. Further, to make the International Week as beneficial as possible, participants will have the opportunity to present a paper/work in progress during a research seminar session.

There is no participation fee. However, participants should cover the cost of travel and accommodation, and, partially, meals (lunch will be provided). Where applicable, the funding might be available from the Erasmus grant distributed by the home university. We invite candidates to check the availability of such funding with their home institution. Please note that the Erasmus+ programme requires visiting lecturers to give at least 8 hours of lectures within the regular courses offered by the host university, some of which might be given under the form of research seminars (it could be possible to give a lecture in more than one group of the same course as well).

To apply, please send an email to international@cunef.edu, indicating as subject line "CUNEF International Week 2024" and including name, academic affiliation, a short bio, link to academic webpage (if any), the topics that best match your lecture and your research interests.

Important dates:

- Deadline for application: June 25th., 2023
- Dotification of acceptance: by July 14th., 2023

Summary of the application procedure:

Step 1: You send us your application with the chosen topics by June 25, 2023.

Step 2: We revise your application to match your proposed lecture/s with the available topics.

Step 3: If you are successful, your application will be accepted for our International Week.

Step 4: Notification of acceptance to be sent by July 14, 2023.

Step 5: Acceptance candidates will be contacted to define all the details of their lectures and seminars, as well as of logistics. For Erasmus financial aid, candidates will be also be required to send the Mobility- and the Teacher-University agreement.
