



Internship durations and official dates

Student Services provide this information at the beginning of each academic year.

Check the details & requirements for your study programme and the year of your course:

- Student handbooks
- Internship report guides
- Course/exam rules & regulations

End of internship

- Final assessment board date = end date of internship contract!
- Make sure electronic file is complete and all deliverables have been submitted in time (company's appraisal, internship report, ...)




















PGE3 / MSc 2 Internship duration

5-6 months in one company between 19/12/2022 and 31/10/2023

OR starting from 13/03/2023 if direct integration into M2 level or after changing MSc specialty

Course requirement

PGE: 9 months work experience in total including at least one long internship of 5 months minimum.

MSc: 5 months work experience minimum in chosen MSc specialty



Formalities

An internship is subject to specific conditions:

- ICN internship agreement refers to specific French labor law
- National insurance registration is required
- Some companies have their own internship agreement 2 or 3 parties
- Employment contract may be accepted in place of internship agreement





Formalities

Internship registration



- Do not start an internship without a signed contract
- Backdated documents will not be issued under any circumstances
- Periods undertaken without a contract cannot be registered
- Partial remote working is accepted if usual at the host company: 60% maximum e.g. 3 days remote and 2 on site per week.



Internships in France

French labor law

- 39 hours a week maximum
- Stipend mandatory for internships over 2 months (more than 44 days or 308 hours):

3,90€/hour or 600,60€ if monthly (154 hour basis)

- May be calculated according to actual hours worked, variable or fixed monthly stipend
- Possibility to take days off according to the company, usually unpaid



International internships

- Working hours and stipend according to local labor law, if existing
- Maximum 45 hours on ICN internship agreement
- Signature of a Letter of Commitment with details of formalities and obligations
- You need insurance for:
 - Illness, hospitalization
 - Occupational accidents (in France includes travel to and from work, occupational disease,
 - Personal accident
 - Medical evacuation
 - Assistance, criminal defense and legal recourse
- Grants such as Erasmus+ (Europe) may be possible
- A visa or work permit may be required: specific procedures like Canada, US, China, UK, ...



French national insurance abroad

Health cover	
EU/EEA/Switzerland /Quebec	Health cover maintained IF you have: - European Health Insurance Card (EHIC) - Form SE401Q for Quebec
Ouside Europe	<u>Partial Reimbursement</u> of URGENT medical costs only, and according to rates in France (visit to the doctor's costs 25 euros) Private, individual travel insurance is very strongly recommended
Cover for occupational accidents & illnesses, travel to and from work	
Stipend no more than 600,60€ gross for 35h	Accident cover maintained if student is registered with the French social security system (CPAM)
Stipend higher than 600,60€ gross for 35h	 Cover via the host company contributions to local system OR compulsory individual registration by student to the CFE



International internships

Current situation and instructions

- Internship feasability dependent on the restrictions enforced in each country
- AND French government restrictions: ministry of foreign affairs, education, ...
- MEAE: https://www.diplomatie.gouv.fr/fr/conseils-aux-voyageurs/conseils-par-pays-destination/
- No ICN internship agreement issued:
 - Regions indicated in red or orange on the country maps ('security' tab)
 - 'Last minute' tab says postpone the trip unless it's an absolute necessity (hors Covid)
- Comply with any specific entry conditions per country: quarantine, compulsory testing, ...
- Total remote working may be allowed if conditions make expatriation impossible or in case of lockdown



Erasmus+ ProgrammeInternship mobility

Conditions for 2022-2023

- From 1st year in Higher Education, studying for a state-recognised diploma:
 ICN Bachelor or PGE (double with MSc accepted), excluding Experience Year
- The mobility cannot take place in the country of study, or in the country where the school is based
- The mobility must end December 2023 at the latest
- Minimum duration 2 months, full-time, expatriation mandatory (daily commute over French border not eligible)
- Open to all nationalities but the host county must be a participating member
- Partner university exchange students should apply to their home university
- Basic internship mobility grant between 420 and 520 euros per month according to host country
- Total of 12 months grant per student and per diploma for an internship and/or a study period abroad

Procedure

Myicn/ internships extranet

- Student begins Assignment form online (basic information)
- Host company fills in the missing information
- Student approves the final version
- Request sent for project's approval by academic tutor
- Final approval by Careers & Internships Office
- Pre-filled internship agreement is signed electronically via Adobesign by all parties



Usual notice required: France 8 days / abroad 2-3 weeks

Internships abroad: Mandatory electronic signature of Letter of Commitment by the student during the Assignment form process

Procedure

Absences:

- Notify the company and ICN
- Provide supporting documents to the company
 - Stipend < 600,60€: medical certificate
 - Stipend > 600,60€: special form (in France IJSS under certain conditions)

Termination:

- Concertation and decision
- Inform the 2 other parties in writing before requesting an amendment



The motive for early termination and each party's agreement is checked before an amendment is issued In case of leaving an internship without a valid reason or unacceptable behaviour

=> Disciplinary measures are taken and academic credits are not granted



Internship agreement amendments

What is an amendment?

The amendment makes official any major changes occuring during the course of the internship

E.g. extension, changes in compensation, different supervisor, ...

Procedure

- Request an amendment by e-mail, indicating the motive and the date the change will come into effect;
 copy to company and academic tutor mandatory
- Amendment is issued by e-mail and is signed by all three parties of the initial internship agreement

Internship portfolio

Before the end of your internship:

- Supervisor receives a link in an e-mail requesting the appraisal form
- Make sure your supervisor submits the appraisal form online
- \triangle
- Fill in from your personal Myicn/ internships account:
 - Self-assessment form
 - Work placement summary

Once submitted, these documents are available to download

The internship assessment is based on the report and the appraisal by the host company



Internship portfolio



Include in your internship report a copy of the company's appraisal AND

a certificate from your host company to confirm completion of your internship – required by French labor law: internship of more than 2 months counts towards retirement

Make sure your portfolio is complete and available for your academic tutor before the deadline indicated by student services





Beware!

Dubious companies - Harassment

- Internship offers: a questionable exchange with the recruiter, doubts about the seriousness of the company
- During the internship: harassment, humiliation, ...

Contact us without delay!



Beware! Duty of secrecy and confidentiality

- Do not use the information collected or obtained for the purpose of publication or communication without the consent of the management of the company, including for use in your internship report
- Do not keep or take away copies, documents or software without the agreement of the company
- Commitment for the duration of the internship but also after its expiry
- Internship report = beware of defamation: once uploaded your report is accessible to the company



Hire

Recruitment at the end of your internship (France):

- Within 3 months: internship duration counts towards trial period (same position)
- Duration over 2 months counts towards total years of service

Recruitment during the internship:

- Internship agreement no longer applies
- All academic obligations must be fulfilled before graduation
- Inform Careers & Internships Service



Graduation

Once graduation is confirmed by the assessment board:

- Internship agreement becomes null and void
- Strictly no further ICN BS internship agreement can be issued
