Editorial



After almost three years of restrictions due to recurrent Covid waves, the academic year 22/23 marked a return to permanent presence, travel to foreign countries, and physical meetings with international colleagues. Nevertheless, the last three years also generated new forms of remote and digital collaboration to be experienced and tested over time. Hence, after the return to (the new) normal, the

current situation has not only opened up new ways of doing research work, but also offered a choice between working together physically or remotely. To an even greater extent, hybrid forms have become standard practice, offering new opportunities to work with partners around the world, although sometimes still with a need to improvise and overcome technical restrictions.

ICN has proved itself capable of meeting this challenge. Conferences like the ARTEM OCC were organized in hybrid format, and the recruitment processes of new scholars was done completely at a distance. Reflection on digital collaboration has become an important research topic, along with the environmental vs social effects of remote collaboration.

Looking back on the recent academic year at ICN reveals significant improvements in many fields. The overall number of teaching and research staff has been increased. The majority of the newly recruited staff put a strong focus on research. They are introduced in the following. Several young colleagues arrived with recently finished PhDs and ambitious research ideas. ICN teaching and research staff represent a global community with colleagues from 25 different countries. Apart from the permanent staff, two new affiliate research professors were welcomed. On the other side, some colleagues left ICN. One particularly noteworthy departure is Paul Shrivastava, who retired from his position as chairholder of the ICN UNESCO chair and as affiliate research professor. Paul played a key role at ICN for years in establishing the topic of creativity and sustainable development from a multidisciplinary approach.

Already in 22/23 the number of ABS/FNEGE/VHB-ranked publications increased significantly in comparison to previous years. In particular, the number of highly ranked articles, ABS rank 3 and 4, increased by almost 50%. 35% of these publications relate to the strategic fields of ICN research, sustainable development, social responsibility, creativity and multidisciplinary. The ICN UNESCO chair of arts and science is in the process of re-evaluation, after a positive assessment by the French national commission. At the joint University of Lorraine and the ICN research laboratory CEREFIGE, two priority research axes run by ICN colleagues - Health & Care, and Creativity &

Sustainable Development - have been established and were positively evaluated by the HCERES audit of the laboratory, in particular their Sustainable Development & Creativity work in close relation with the ICN UNESCO chair. Several ateliers, workshops and colloquia were organized related to arts, science, and sustainable development.

The reputation of the journal RIPCO, edited by ICN, continues to grow as it establishes a foothold in the competitive market of international management journals. Meanwhile, it has been ranked as a FNEGE category 3 journal.

The number of external funded research projects increased as well, particularly ANR- and EU-funded projects (see description below). Several project applications are currently under evaluation. Particularly, international projects like ERASMUS+ lead to new collaboration relations and bring about new research networks.

The Research Management Committee, featuring representatives from all departments, has been very active in framing and facilitating research inside ICN. Worth mentioning is the transfer from the CNRS journal ranking to the more international ABS list in combination with the FNEGE ranking and the German VHB journal. Furthermore, an ethical code for research has been passed, and ICN was one of the very few business schools to sign the French Charter for Research Integrity.

Communication on research activities and results internally and externally has become an important driver for ICN. This involves not only presenting work at conferences and publishing in academic journals, but also conveying research results to the non-academic world. As part of this move, the academic year 22/23 saw the launch of the newsletter "Research Insights", which summarizes research articles and research topics in non-academic language. Inside ICN, the "research coffee break" was established as a perceptive encounter on emerging research topics and projects.

The developments of the last academic year can be seen as marking promising progress in research at ICN to cope with upcoming challenges. Key focus areas in the next few years include the strengthening and establishing of research clusters, the securing of externally funded research projects, and the integration of a growing number of teachers and researchers distributed among three campuses.

The current positive developments would not have been possible without the team spirit and engagement of our academic staff, and the support of our administrative staff in academia and research.

SUPPLY CHAIN MANAGEMENT AND INFORMATION SYSTEMS



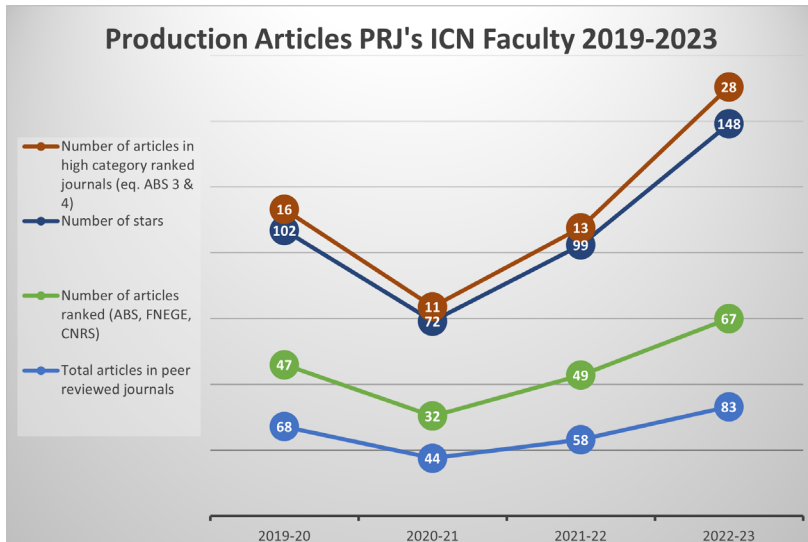

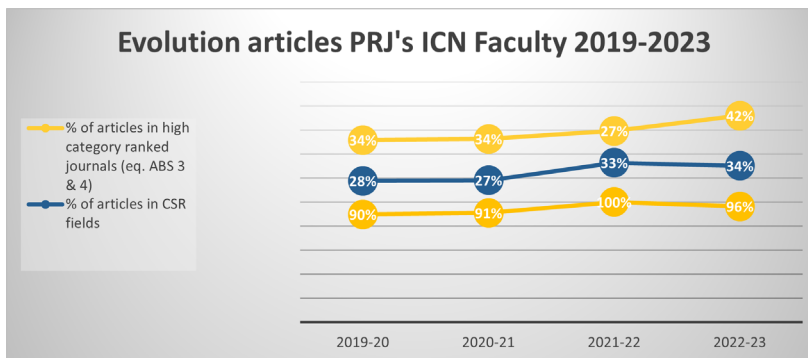
Research Outputs

The number of publications has increased significantly. Compared to 2021/2022 article publications have been increased by around 50% as well as the number of high level publications, increase of + 15% in 3* and 4* journals.

It is particularly important to mention that these high-level publications are not only the outcome of just two or three researchers but are distributed widely among the faculty. It shows that high quality and productivity are found throughout the faculty. The number of submissions to these journals is also increasing.

The aim of the conference is to compare the views of applied research and professional expertise, and to build bridges between the world of research and that of economic and social players.



May 2023 - RevEll'East – Women entrepreneurs Hackathon Led by Krista Finstad-Million

As in 2022, the Hackathon took place on three sites in the Grand Est region: Nancy, Reims and Strasbourg. This year's Nancy edition took place on May 23, 2023 at Station A, supported by ICN's Centre for Digital Transformation and Entrepreneurship (CFDTE) and contributing to ICN's UNESCO Chair Art and Sciences for Sustainable Development Goals. Partners included: Orange, ICN, EST'elles Executive, Alsace Digitale, 1Kubator, SEMIA, EDF, Laetitia Lhermite, Le Village by CA Reims, and INNOVACT. The event can be described as a co-creative marathon dedicated to women's entrepreneurship in the Grand Est. The objective is to encourage women in the region to create new businesses and help ideas for new enterprises emerge within 9 hours. The method encourages emulation between teams of participants around a project. This year a group of female high school students and their teachers participated in the day. Key Nancy figures: 10 facilitators, 8 coaches, 20 participants, 13 project holders, 7 projects selected, 8 prizes, 3 prize winners. Key figures for the 3 sites: 90 participants, 31 project holders, 25 facilitators, 18 coaches, 16 projects selected, 9 prize winners and 23 prizes.

Towards an Industry of the future

Led by **Benoit GRASSER** (Université de Lorraine) and **Jean-François STICH** (ICN), the VIVERES project aims to explore the potential of cobots (a contraction of the terms 'collaborative' and 'robots') in the context of a green industrial transformation.

Given that the on-board intelligence of cobots is 'open' and that they offer great flexibility in terms of integration, what prospects do they offer for the organisation of work and individual and collective skills within companies? What are the points to bear in mind when deploying them? Can we bank on cobots as part of the ecological transition that the Industry of the Future is so keen to see? More generally, what lessons can we learn about the transformation of work and the managerial practices of the future?

Le jeu de l'épargnant

The 'Jeu de l'épargnant' applied research programme aims to gain a better understanding of people's savings and wealth accumulation behaviour by considering their preferences and attitudes to risk, their life plans and their ability to project themselves into the future.

This research programme is part of the People Leadership axis of the Unesco Arts & Sciences Chair in the context of the Sustainable Development Goals, directed by Hélène Xuan. As part of this project, we are using the ATM (Art-Technology-Management) workshop methodology to gain a better understanding of the impact of the decision-making environment on individual rationality and imagination, so that we can better inform our savings decisions and support savers in their life projects.

In addition to our contribution to existing knowledge on investor behaviour, we are also committed to building bridges between academic research and the economic and social world, through public debates between researchers, professionals, elected representatives and artists, in order to cross-fertilise perspectives and anchor our work in the questions and concerns of professionals and individual investors. And also to disseminate the results of our work in the form of ATM financial education workshops.

This project benefits from private funding from its founding partners Préfon and Harvest. It will run for 4 years (2023-2026). It is also supported by the ICN endowment fund, which aims to promote the development of a community of change agents around Art and the Sustainable Development Goals (SDGs) and, particularly for partnership research, to make the results and new methodologies of applied research accessible and useful to businesses and politicians.

Since January 2022, the Grand Est region supports ICN under the project CDTE (Centre for Digital Transformation and Entrepreneurship)

ICN continues its commitment to being an active player in the region to meet the aspirations of our ecosystem in terms of entrepreneurship and digital transformation. and

Within the framework of the activities of the CDTE (Centre for Digital Transformation and Entrepreneurship) led by Wolfram BERGER, Kamel MNISRI and Klaus-Peter SCHULTZ, the 2022/2023 academic year was rich in events and actions that strengthened ICN's territorial impact.

In 2022/2023, 73 students benefited from the CDTE's expertise in creativity and innovation methods as part of international seminars dedicated to sustainability-oriented innovation. As part of this, the students worked in partnership with a foreign car manufacturer on a design problem for the car of the future.

Also, as part of its support for entrepreneurship, the CDTE was co-organiser of the "Entrepreneurship with an impact on the social economy" challenge. This challenge was open to all ICN students, across all programmes and campuses. In the case of the Revell' East hackathon, the CDTE's expertise was useful in supporting the project leaders and encouraging them to think holistically about all the stages in the life cycle of the entrepreneurial journey and beyond, and to fit the business creation project into its ecosystem.

The CDTE's activities also include strengthening ICN's relations with its ecosystem. As part of this, a seminar dedicated to redefining and rethinking entrepreneurship in the Nancy metropolitan area was organised. This event brought together 23 representatives of structures dedicated to supporting entrepreneurship in the region. The CDTE also organised a creativity workshop for an organisation with expertise in innovation in Greater Nancy and its economic bas



Mars 2023 – ITeachWell – An Erasmus Plus project

The transnational "ITeachWell" project, funded by ERASMUS+ and coordinated by ICN Business School (Jean-François STICH being the project leader) is studying technostress in secondary education and developing tools to help teachers cope with the stress generated using technology.

During the academic year 2022-2023, data on technostress was collected from European partners (France, Italy, Spain, Bulgaria and Latvia). Teachers from these collèges and lycées have also been able to take part in discussion groups on these subjects. The partners are currently working on creating an e-learning platform for teachers, where tools and results will be shared.



PROJECTS IN PROGRESS



The UNESCO Chair "Art and science in the context of sustainable development objectives" is rolling out an action research programme on "responsible and innovative management of public organisations" entitled ResINN over the period 2022-2025.

Manag'Est, the Grand Est Region's management school, which also provides support for regional development projects, is providing the groundwork for the research: the "Internats du Futurs" project, the "Avenir du Massif des Vosges" project, and the introduction of the new profession of "Regional Project Developer".

Two areas of research are being developed:

- ▶ Sustainable managerial innovations to promote a learning organisation and organisational ambidexterity within public organisations: an approach based on ethics, and humanist and deliberative management.
- ▶ Facilitating cooperation in the development of regional macro-projects: Encouraging and evaluating the use of artefacts, the symbolic, the imaginary and the artistic.

This programme is the subject of a multi-year partnership agreement between ICN and the Grand Est Region. CIFRE-Manag'Est funding for a CEREFIGE doctoral thesis is in addition to the programme grant.

The partnership will result in scientific publications and the drafting of a research report "on organisational practices and their evaluation to move towards responsible and innovative management in public organisations", using artistic artefacts in particular.

The ICN PhD programme – Student into responsible researcher

ICN PhD in Management (Doctor of Philosophy in Management)

The ICN PhD programme is rigorous: and challenging. It transforms students into responsible researchers who contribute to the development of contemporary, creative and innovative knowledge in management and business in an international context. It encourages creativity in the topics and methodologies, consistent with the school's transdisciplinary #ATM (Art Technology Management) perspective.

At the end of a final workshop in May 2023, the 14 students of the 2022-2023 class were able to present the progress of their doctoral work individually.

Elisabeth PAULET, director of the programme, and all the professors congratulated the students, who will continue their training next year. This year's intake was highly eclectic, comprising 3 Lebanese students, 4 Iranians, a Nigerian, a Luxembourger, a Ghanaian, a Tanzanian, a Greek, an Uzbek and a Frenchman. More than 160 applications have already been received for the start of the new school year.



The DBA (Doctorate in Business Administration) – Entirely online programme

The DBA in Sustainable Innovation Management is delivered jointly by ICN Business School and the Business Science Institute (BSI), Luxembourg.

In addition, our DBA is offered as a dual degree programme with IAE Lyon, the School of Management at the city's Jean Moulin University. DBA graduates receive both a university degree of Doctor in Business Administration from Jean Moulin University and the title of Executive Doctor in Business Administration from ICN & the Business Science Institute.

The DBA programme is designed for senior executives, managers, consultants, and management educators with at least five years of management experience and qualified at Masters, or MBA level (or equivalent).

The Online DBA in Sustainable Innovation Management is organised in three different stages and is normally completed in **four years**. Learning resources are accessed on our virtual learning platform (videos, articles, books, data analysis software, participant forums), enabling students to work remotely at their own pace. Throughout the entire duration of the programme, students are guided and mentored by an experienced faculty member. Monthly online feedback meetings guarantee close, regular monitoring of student progress up to graduation.
